4th Meeting of the Advisory Committee : Action Taken Report



Recommendations of the Advisory Committee	Action Taken
<p>Regarding issue of coverage of Credit Guarantee Scheme the Committee was of the view – publicity of the scheme should be enhanced so as to create requisite awareness at the branch level of the banks. Secretary (MSME) desired that a meeting with the bankers should be organised.</p>	Noted
<p>In Agenda No. II and Agenda No. III there was proposal for amendment in Notification No. S.O. 1642 (E) dated 29.9.2006 regarding classification for MSME and certain procedural modification in regard to filing of EM</p>	Action has been taken
<p>The National Commission Enterprises in Unorganised Sector proposed for creation of a national fund for the unorganised sector (NAFUS) which will cater to the development needs of the unorganised sector in the areas of credit marketing skill development, technology upgradation refinance, factoring services and infrastructural development .an inter-ministerial group was constituted for this purpose. In case the proposal for creation of NAFUS is accepted, the same could be notified under section 14 of the MSMED Act.</p>	Not considered

Action Taken Report – cont.

Recommendations of the Advisory Committee	Action Taken
<p>Section 26(1) of the MSMED Act, 2006 provides that the Central Government or the State Government may appoint such officers with such designations and such other employees as it thinks fit for the purpose of this Act and may entrust to them such of the powers and functions under this Act as it may deem fit. Section 26(2) further provides that the officers appointed under sub-section (1) may, for the purpose of this Act, by order require any person to furnish such information in such form, as may be prescribed.</p>	Action Taken
<p>The Committee noted that after the promulgation of the MSMED Act, 2006 w.e.f.2 October, 2006, the implementation of the various provisions of the Act is rather slow, For instance, despite vigorous persuasions at the level of Minister (MSME) with the Ministers incharge of MSMEs of the States, Secretary (MSME) with the Chief Secretaries of States/UTs and Development Commissioner (MSME) with the Principal Secretaries/Secretaries (Industries) of the States/UTs. 32 States/UTs have notified the authority for filing of EM, 21 States/UTs have notified the Rules for MSEs and 19 of them have constituted the MSEFCs. The Committee desired that the Ministry of MSME may take up the matter with the States/UTs where these provisions are yet to be implemented.</p>	Action Taken
<p>Further, the Committee was informed that representations have been received from the associations of many States that the spirit of the MSMED Act, 2006 is not being followed by the State Governments while issuing the acknowledgement of the EM filed by the entrepreneurs /industrialists. In many instances it had been reported that the EM filed by the MSMEs is not even being accepted by the GM, DICs. It was decided that a fresh advisory in this regard may be issued by the Ministry of MSME.</p>	Action Taken

Existing System of Registration

As per MSME act of 2006 all enterprises are expected to register with DIC in their area and file Entrepreneurs Memorandum (EM)1 for intention to start business if manufacturing or service and file EM2 after starting production.

EM 2 filing is mandatory for Medium enterprises only.

Introduction : Ease of EM Registration

- For over 658 revenue district and 644 DIC across 36 States and UT only 13 like UP Guj Mah KN TN AP Kerala etc) have some forms of Web enabled EM Filing but fewer have automation based on work flow and dispensing manual filing in addition to electronic version.
 - State specific
 - No national database
- NIC developed system has been put to test in Odisha and now being rolled out for all States and UTs depending upon their readiness to adopt. National portal for on-line filing of EM-I and EM-II (Nov 14)
- National Portal is adopted by 14 States and UT
- Over 59834 EM1 and 15667 EM2 filed online
- DIC need to be empowered with definite time lines to dispose including rejection or denials with reasons

Prime Minister's 'Man Ki Baat' on 3.10.2014

“Lot of suggestion are received by me, some of them are very interesting. Some people have suggested that the process of registration for small scale industries should be simple. I will bring it to the notice of the government.”

Report of the Kamath Committee on Financial Architecture of MSME sector ;
Chapter 8 (Para 2) : Universalization of Registration

‘The proposed National MSME Portal can then require only a simple one-page registration form for MSMEs with a simplified set of information and documents. With the growing penetration of mobile phones in the country and the incremental usage of data services on mobile devices, this portal should also be easily accessible through mobile platforms’.

- National MSME Portal is proposed for simplification of registration as one-page registration form for MSMEs
